



EDITOR'S NOTES

In this issue we have an all encompassing, tremendously well illustrated article on Belgian Congo Maritime Mail by Danny van der Hauwaert.

By fortunate coincidence we are able to accompany the article with Walter Deynckens catalogue of Ships cancellations (with thanks to E. Hoorens for the Flemish-English glossary).

Frenay's inventory of known "Tombeur" covers is a valuable reference for us all (with thanks to Don Campbell for his continued service as translator of French texts).

I call your attention to the questions raised by Charles Stockmans. If any member has the answer to any of the questions—such answer will be a positive step forward in Belgian Congo Philatelic knowledge.

With this issue I shall retire as your Editor.

A review of the history of the Bulletin shows that in its inception Ray Keach acted, not only in every conceivable capacity as to the Circle's affairs but also in writing for and in publishing the Bulletin from 1951 to April of 1976. Then the late Peter Foden took over until April 1977. Stuart Smith published bulletins 30 through 34 in the period 1977 to November 1979. The late Ralph Jacquemin then began the regularly published series serving as Editor from March 1980 through June of 1990 issuing numbers 35 through 76,

My first bulletin was number 77 and this, my last, is number 119. In Editing I was able to refer to those articles and works of the many who had gone before—they were of great help.

In those years I have had the privilege of personally meeting so many of our present contributors that I hesitate to list them for fear I might omit someone. Not only am I, but we all are in their debt. I also knew those who are no longer with us; Foden, Vindevogel, Jeukens, Hudson and Celis. It has been a fulfilling personal and philatelic experience.

Particularly I drew on Ray Keach's vast knowledge of both the stamps and his understanding of the problems involved in producing a Bulletin. No issue was ever published which did not have his imprimatur—in most cases his Vice President's column and in all cases his review and suggestions as to my work. Without his assistance the task would have overwhelmed me.

After eleven years and forty two Bulletins it is time for fresh ideas and a fresh approach. I have recommended to the AGM Ron Strawser as my successor. He has a broad knowledge of Belgian Congo Philately with particular expertise in Postal History—I look forward to working with him in the transition and to his future productions.

I have also recommended to the AGM David Schaubroeck as the American agent to collect subscriptions and presume he will undertake his duties in the year 2002. I will finish the year 2001 and will also continue to act as the transmission agent for successful American bidders in our Auctions.

I thank all who made my work easier—all who contributed to make the Bulletin interesting and informative—your numbers are legion and it is you who remain the life blood of the Belgian Congo Study Circle.

I trust that time will now permit me to water my orchids more regularly—to return to some long neglected woodworking projects and to complete some plating and forgery studies which have for much too long a period been relegated to that file called "future projects". Perhaps I will be able to generate and article or two which will be of interest.

As Mr. Keach has often described a term of office—"I've had a good run." Again I thank you all.




BELGIAN CONGO: MARITIME MAIL

1. Ships.

a. The postcard below shows a picture of the Leopoldville (3); the same picture can be found in Abbé Gudenkauf's booklet 'Mailboat services from Europe to the Belgian Congo (1879-1922)', top of page 73.



The picture below is taken from an article from W. Deynckens in 'Belgica no. 127, avril-mai-juin 1986' and shows exactly the same ship but this time called Bruxellesville (2).


Mentioned is: Card written on board of the Bruxellesville and posted in Southampton.
I only have another postcard from the Leopoldville 3 and I think the above pictures are also
Leopoldville 3 but I'm not sure; who can help.

b. Below a postcard with the picture of the S.S. Leopoldville; the card has a 'La Rochelle – Pallice cancellation' dated 13/2/10 and from the text it's clear that it was send during an outward journey to Congo; from the tabulation (Stockmans – Gallant) we can see that the Leopoldville 4 left Antwerp 10/2/10; so up to now everything fits. But comparison with other pictures of the Leopoldville 4 made clear that it could not be this ship; also comparison with the Leopoldville 3 is giving no results.




The best results I get when I compare it with the picture below which is the Albertville 3. Chimney, number of lifeboats, number and position of port-holes are fitting.

Looking in Gudenkauf's booklet on page 49 bottom, I think it is not the Albertville 2 but also the 3; has somebody some other information?

2. Cancellations

a. Leopoldville



Postcard with 'La Rochelle – Pallice cancellation' dated 7/11/11 and S.S. LEOPOLDVILLE cancellation as mentioned in Du Four page 439; Du Four states that the cancellation was seen on a stamp of the 'Etat Independant du Congo' meaning it was used before or in 1909 at latest; this card showed its usage up to for sure 1911.

As a result, in 1911 were used at least 3 different cancellations on board the Leopoldville:

- the above straight-line S.S. LEOPOLDVILLE



- the (rare) circular type 2 cancellation with separate date line


- the straight-line PAQUEBOT LEOPOLDVILLE (77 x 4 mm) also seen in 2 parts: PAQUEBOT (31 mm) and LEOPOLDVILLE (43 mm). La Rochelle – Pallice cancellation 17/6/11.



- I don't know if the straight-line LEOPOLDVILLE (40 x 3 mm) was already used in 1911.



b. Unknown cancellations

Cancellation 'COURRIER DE HAUTE MER' and in the middle 'PAQUEBOT' without the name of a ship.

The back side has the same cancellation (very faint) on the 'stamp' (10c – Stibbe 43).

There is no date and the card was sent to 'Anvers – Belgique'.

Has anyone else seen such cancellation?



Vloors 1F stamp with red circular COURRIER DE HAUTE MER – ALBERTVILLE cancellation type 8 (point at the bottom), used on board of the Albertville 5 during the period 1928-1940.

Additionally there is a straight-line cancel ALBERTVILLE also in red, measuring 36 x 6 mm.

Has somebody seen this before?

3. Specialties


a. It is known that in the years before the second world war, the CMB had to many ships travelling between Belgium and Congo; for that reason the Leopoldville 5 and Albertville 5 were used for a number of cruises. Below a part from the frontside of an envelop, used by the

Les timbres "TOMBEUR" et Entiers Postaux furent surchargés à Pambani par le Sous Lieutenant PIRSH à partir de la fin du mois d'Août 1916 suivant l'ordonnance du Général Tombeur du 11 juin 1916 créant les services des postes militaires dans les territoires occupés.

Les timbres et entiers postaux furent officiellement mis hors cours le 1 janvier 1917. Cependant une tolérance permis d'utiliser les timbres jusqu'en fin janvier 1917 et les entiers postaux jusqu'en mars 1917 pourvu que le lieu de départ soit bien l'Est Africain Allemand, occupé par les troupes belges, et non le Congo;

Translation of the Introduction on page 1A and of the NB note on page 2C by Donald Campbell

I. Introduction-Page 1A

The "TOMBEUR" stamps and postal stationery were overprinted at Pambani by Second Lieutenant PIRSH from the end of the month of August, 1916, following the order of General Tombeur of June 11, 1916 creating the military postal services in the occupied territories.

The stamps and postal stationery were officially invalidated on January 1, 1917. However, an indulgence permitted use of the stamps until the end of January, 1917, and the postal stationery until March, 1917, provided that the place of departure be German East Africa, occupied by Belgian troops, and not the Congo.

II. "N.B."-Page 2C

The overprints called "TOMBEUR" were badly perceived by our English allies, whence the reason for their withdrawal 1-1-1917. In reality, the allies had decided that the division of the conquered territories would be made only one time, (after) all completed operations. But the act of overprinting of the stamps or stationery of the Congo in the name of the two occupied regions might lead one to think that the Belgians had already made a plan for the partition.

Stamps overprinted typographically at Haye with the overprint EST AFRICA ALLEMAND-OCCUPATION BELGE
DUITSCH OOST AFRIKA-BELGISCHE BEZETTING
arrived at the front at the end of October, 1916.
